\*The new tax rate for 2025 has not yet been established by the Board of Supervisors and will be established in a public meeting of the Board of Supervisors more than 60 days from the date of reassessment. The date and time for the public hearing to establish the new tax rate will be advertised in a local newspaper serving Madison County and the County web site ([www.madisonco.virginia.gov](http://www.madisonco.virginia.gov)), at least one week prior to the public hearing. It is anticipated the public hearing will be on April 8<sup>th</sup>, 2025, at 4:00 PM, and that the tax rate will be adopted on April 22<sup>nd</sup>, 2025, at 6:00 PM. The meeting will be held at Board of Supervisor's Auditorium, 414 N. Main Street, Madison, VA.

#### TAX RELIEF FOR ELDERLY, DISABLED, AND VETERANS

The County of Madison has a tax relief program for the elderly, disabled, and disabled veterans. Applications must be completed and submitted to the office of the Commissioner of the Revenue by April 1, 2025. Disabled veterans may apply throughout the year. #### ASSESSMENT APPEALS

The amount of assessment change is not, of itself, an indication of an assessment error. However, if there is evidence to suggest that the new assessment shown is higher than the present market value of your property or is not uniform or in line with similar properties in your area, you may wish to appeal your assessment during the Assessor's Hearings. Comparable assessments are available at Madison County's website [www.madisonco.virginia.gov](http://www.madisonco.virginia.gov). Values may be raised or lowered during these hearings, in order to maintain equalization. Property owners have the right to view and make copies of records maintained by the local assessment office pursuant to Title 58.1-3331 and 58.1-3332 of the Code of Virginia. The records available and the procedure for accessing them are set out in the above referenced Titles.

#### ASSESSOR'S HEARINGS
