**Explanation of FY26 SA#01:**

We will receive \$69,330 in additional revenue from the State for the following:

1. One-time bonus reimbursement expected from the State = \$27,483. This amount was not captured in the FY26 approved budget because the total was not known until June 16.
2. Clerk of the Circuit Court will receive full funding for a fifth position that the County has been supplementing. The additional revenue is \$41,847. On the expenditure side, a total of \$28,959 in salaries plus benefits is already appropriated in the Clerk of the Circuit Court's FY26 expenditure budget. Therefore, only \$12,888 in additional expenses needs to be appropriated for this fifth position and in order to accept the COIN reimbursement amount.

We need to (decrease) revenue by (\$5,015) in the Registrar's office because of an error in the state reimbursement budget calculation.

We need to increase/(decrease) expenditures by a total of \$16,626 in the following departments:

1. Clerk of the Circuit Court = \$15,032 - additional funds needed for salaries & wages plus fringe benefits to cover increased pay & benefits related to COIN reimbursable positions = \$12,888; plus additional funds needed for one-time bonuses = \$2,144
2. Registrar = \$2,149 - funds needed for one-time bonuses
3. EOC-911 = \$380 - additional funds needed for one-time bonuses
4. Sheriff's Department = (\$935) - decrease salaries & wages plus fringe benefits for overestimating one-time bonuses during the budget process.

We are able to increase the Contingency Fund expenditure budget by the remaining amount of \$47,689, bringing our new Contingency Fund budget figure from \$269,244 to \$316,933.
