In FY25, Madison Schools received a School Improvement Grant (SIG) in the amount of \$107,705.22 for grades K-8. The grant could be spent in FY25 and in FY26 through September 30. Expenditures incurred and state reimbursements received in FY26 total \$38,418.78 and need to be added to the FY26 budget.

Dear Clay:

In FY24, the State awarded each school system funds for instructional expenses to be spent in FY24, FY25, and FY26 or until the funds run out, whichever came first. The Schools received \$509,279 in FY24 and spent \$138,640.54 in that same year. In FY25, \$370,639 was carried over to the FY25 budget and \$306,876.06 was spent in that same year. This leaves a remainder of \$63,762.94 to move forward to FY26 for student instruction that was not included in the original FY26 budget. The entire ALL in VIRGINIA funding will be spent in FY26.

Last evening the Madison County School Board approved a request to ask the Madison County Board of Supervisors for a total supplemental appropriation in the amount of \$63,762.94. We ask that it be added to the 1000 Instruction Function.

Dear Clay:

Last evening the Madison County School Board approved a request to ask the Madison County Board of Supervisors for a supplemental appropriation in the amount of \$172,557 resulting from unspent textbook funds from FY25. We ask that this amount be added to the separate Textbook Fund Bank Account for future use. The information that permits this transfer is the following:

Chapter 725, 2016 Acts of Assembly permits school divisions that have met required local effort and required local match for fiscal year 2025 to carry forward to fiscal year 2026 any remaining state textbook fund balances that are unexpended as of June 30, 2025. Item 136 C.5.f.4 provides separate carry forward authority for the Textbook account, which reads as follows: *"Any funds provided to school divisions for textbook costs that are unexpended as of June 30, 2025, shall be carried on the books of the locality to be appropriated to the school division the following year to be used for same purpose. School divisions are permitted to carry forward any remaining balance of textbook funds until the funds are expensed for a qualifying purpose."*
