Site Contingency	Some of the risks that were identified last fall have been mediated by the passing of current towers at Blakey and Beautiful Run. Most of the risks at this point fall in to PRA (Fiber Connection) and Hughes River (Site Work). There are some savings here that we are not standing a tower up at the ECC. BDA Contingency	Building Coverage in all four schools in the event that the system doesn't penetrate, numbers are ball park estimates and not hard numbers. Based on achieving 100% coverage which we may not need. Upgrading existing BDAs at Woodberry and Plow and Hearth. I believe we are obligated to upgrade current systems.
