

In lieu of submitting an Erosion and Sediment control plan for the construction of a single family residence and/or improvements with a disturbed area of ten thousand (10,000) square feet or more, I agree to comply with the requirements of Madison County Erosion and Sediment Control Ordinance and the Virginia Erosion and Sediment Control Regulations and to install erosion measures in accordance with applicable standards and specifications in order to protect against the transport of soil and sediment. I further agree to comply with any additional requirements deemed necessary to provide adequate control of erosion and sedimentation on or resulting from this construction. Erosion controls required shall be installed as a first step in the construction process and prior to a request for a footing inspection.


As a minimum:

1. A stone construction entrance shall be provided wherever traffic will be leaving a construction site and transporting mud directly onto a public or private road or other paved area. Any mud transported off the site will be cleaned up promptly.
2. Silt fence or other protective measures shall be provided wherever sediment from disturbed areas may leave the site. Such protective measures must be provided before significant land disturbing activities may proceed.

3. All denuded areas shall be stabilized within seven (7) days of final grading with permanent vegetation or a protective ground cover suitable for the time of year. Temporary soil stabilization shall be applied to denuded areas that may not be at final grade but will remain undisturbed for longer than fifteen (15) days.

* Perennial Ryegrass will germinate faster and at lower soil temperatures than fescue, thereby providing cover and erosion resistance for seedbed.
 ** Use seasonal nurse crop in accordance with seeding dates as stated below:
 March, April through May 15th Annual Rye
 May 16th through August 15th Fostail Millet
 August 16th through September, October Annual Rye
 November through February Winter Rye

I understand that failure to comply with this agreement may result in civil penalties and may require the submission and approval of an erosion and sediment control plan, the engagement of a Responsible Land Disturber, and a performance bond for the total cost of grading, drainage, erosion and sediment control, and remedial work.

I hereby grant the County of Madison and its agents or inspectors the right to enter upon the aforesaid parcel of land to assure compliance, including performing remedial work if the Owner/Agent fails to comply with directives of a Madison County erosion control inspector. I further agree to pay for all cost for such remedial work within fourteen (14) days after receipt of invoices received for such work. **The permit will expire one year from date issued.**

I understand disturbance equal to or greater than 1 acre of disturbance requires 2014 Construction General Permit coverage under the Virginia Stormwater Management Program.
