**ORDER**

Michael C. Garnier died on November 9, 2019. His body is currently in the possession of the Madison County Sheriff's Department. The Madison County Sheriff's Department made a good-faith effort to identify and notify his next of kin, but they did not identify any. No other responsible party is willing and able to dispose of the remains. The Officer of the Chief Medical Examiner has declined to take the remains. The Madison County Sheriff's Department has made arrangements with Preddy Funeral Home for disposal of the remains, at the cost of \$2,238.45.

It is therefore ordered that the Madison County Sheriff's Department follow through with these arrangements for the proper disposal of the remains of Michael C. Garnier.

It is therefore ordered that this cost be assessed against the estate of the deceased, in accordance with Code of Virginia § 32.1-309.2(E). The funeral expenses may be paid from any bank accounts in his name. Any funds seized from those accounts, and any estate assets or money seized shall be turned over to Preddy Funeral Home for the \$2,238.45 in funeral expenses incurred under the agreement between the funeral service and the Madison County Sheriff's Department.


